

## Dog Waiver

(This Agreement applies to domesticated dogs other than Service dogs)

I hereby agree to the following regulations and restrictions while staying at Admiral Hotel:

- My pet is a domesticated dog that weighs no more than 40 kg/88 lbs.
- No more than two dogs are permitted in my room, together up to 40 kg/88 lbs.
- I understand that I will be charged 75 HRK, per night for my dog. This fee is non-refundable. I understand that additional fees may apply should my dog cause any damage.
- The dog bed, bowls and mat are only provided for the duration of stay and belong to the Hotel.
- I agree to keep my dog on a leash or in a pet carrier while using public areas of the Hotel.
- I understand that dogs are not permitted in the Restaurant, Bar, Meeting Point area, Relax Zone and Grand Casino.
- I acknowledge that I will walk my dog to relieve it of bodily functions on the outer perimeter of the Hotel property, away from the building facade and flower beds. I am also responsible to properly remove and dispose of any litter or waste associated with my dog on Hotel premises.
- I must notify the Front Desk and hang the "Do not disturb, my dog is resting" door hanger when I leave my dog unattended in my room.
- I agree to be present, while any member of the personnel such as Housekeeping, Room Service or Maintenance is present in the room. Room cleaning must be scheduled for a time when the dog is not in the room or the owner is present.



- As a responsible pet owner, I agree to accept full and complete responsibility for any personal injury or property damage caused by the dog and suffered by any guest, employees or invitees to the Hotel, during my stay at the Hotel.
- I understand that the costs for the repair of any damages or additional cleaning requirements caused by my dog's behaviour and presence in the Hotel, will be charged accordingly. This includes flea treatment of the room. I hereby authorize the Hotel to charge my credit card for such surcharges, even if they are discovered after my departure from the Hotel.
- I agree to prevent noise or any further disturbance by my dog, in the interest of other Hotel guests. Furthermore, I agree to pay for any loss of revenue, caused by an early departure of other Hotel guests, who felt disturbed by my dog.
- I agree that, should my dog create any disturbances which cause complaints by other Hotel guests or personnel, at the request of Hotel Management, I shall immediately make arrangements to house the dog outside of the Hotel. Otherwise, I will be asked to leave the Hotel without reimbursement.
- I understand and agree, that the Hotel retains the right to exclude my pet if, at the Hotel Management's sole discretion, my dog is considered dangerous or is likely to frighten or harm other guests of the Hotel.
- I acknowledge, that my dog has received and is current with all required shots and immunizations and confirm that the dog does not have any communicable illnesses or diseases. I can produce those records if required at any time during my stay.
- I release Admiral Hotel from any and all liability for any injury and/or damage suffered by my dog during my stay at the Hotel.
- I agree, that at all time while on Hotel property I will ensure that my dog complies with all relevant laws and regulations of the Republic of Croatia.

## Izjava o suglasnosti

Ovim sporazumom pristajem na navedena pravila i ograničenja prilikom boravka u Admiral Hotelu:

- Moj pas je pripitomljeni ljubimac (domaći pas) koji ne teži više od 40 kg/88 lbs.
- U sobi nije dozvoljen boravak više od dva psa, ukupne mase do 40 kg/88 lbs.
- Upoznat/a sam da će boravak psa biti naplaćen 75 HRK po noćenju. Ova pristojba je nepovratna. Također sam svjestan/na da će svaka šteta koju pas izazove tijekom boravka u Hotelu, biti dodatno naplaćena.
- Krevetić, zdjele za hranu i podmetač za psa su na raspolaganju za upotrebu samo tijekom boravka u Hotelu te su vlasništvo Hotela.
- Suglasan/na sam da prilikom boravka u javnim prostorima i prostorijama Hotela držim svog psa na povodcu ili u nosaču za kućne ljubimce.
- Upoznat/a sam da psima nije dozvoljen ulazak u restoran Taurus, The Bar, Meeting Point (sobe za sastanke i konferencijsku salu), Relax zonu te Grand Casino.
- Potvrđujem da ću svog psa voditi u šetnju izvan Hotela, na dovoljnoj udaljenosti od fasade i biljnog raslinja Hotela, kako bih omogućio/la normalan rad njegovih tjelesnih funkcija. Odgovoran/na sam i za uklanjanje svakog otpada koji nastane od moga psa u unutarnjim prostorijama i vanjskom prostoru Hotela.
- Ukoliko namjeravam ostaviti psa bez nadzora u sobi, o tome sam dužan/na obavijestiti Recepciju Hotela te na vrata sobe staviti od strane Hotela dobivenu oznaku: "Molimo, ne ulazite. Iako smo izašli, naš pas je u sobi i odmara."
- Potvrđujem da ću biti prisutan/na ako je član osoblja Hotela (Odjel održavanja i čišćenja soba, Sobna posluga ili Odjel održavanja Hotela) zbog bilo kojeg

- opravdanog razloga u sobi. Čišćenje sobe mora biti dogovoreno u vrijeme kada pas nije u sobi ili kada je u sobi zajedno s psom i njegov vlasnik.
- Kao vlasnik/ca psa, preuzimam punu i potpunu odgovornost za bilo kakvu štetu koja uslijed djelovanja moga psa nastane u vidu fizičke ozljede nanesene nekome od gostiju, zaposlenicima ili uzvanicima Hotela, kao i u slučaju bilo kakvog oštećenja na imovini Hotela.
- Upoznat/a sam da će troškovi popravka oštećenja uzrokovanih od strane moga psa ili dodatni troškovi čišćenja uzrokovani boravkom moga psa, biti dodatno naplaćeni. To uključuje i tretman protiv buha. Ovim sporazumom dajem ovlasti Hotelu za terećenje moje kreditne kartice za takve dodatne troškove, čak i ako su oni otkriveni nakon mog odlaska iz Hotela.
- Suglasan/na sam da ću spriječiti bilo kakvu buku i smetnje koje bi moj pas mogao izazvati, a koje bi mogle smetati ostalim gostima Hotela. Osim toga, slažem se platiti bilo kakav gubitak prihoda Hotela zbog ranijeg odlaska drugih gostiju koji su se osjećali uznemireno radi ponašanja moga psa.
- Suglasan/na sam da ću, u slučaju da moj pas stvara smetnje u Hotelu koje rezultiraju pritužbama gostiju ili osoblja, na zahtjev Uprave Hotela, osigurati smještaj svoga psa izvan Hotela. U suprotnom, biti ću zamoljen/na napustiti Hotel bez prava na povrat novca.
- Upoznat/a sam i suglasan/na da Uprava Hotela ima diskrecijsko pravo ukloniti psa iz Hotela u slučaju da se pas smatra opasnim ili postoji opasnost da bi mogao naškoditi ili zastrašiti ostale goste Hotela.
- Potvrđujem da je moj pas primio sva potrebna cjepiva i imunizacije te da nema zarazne bolesti koje se prenose kontaktom. Ukoliko je potrebno, tijekom mog boravka u Hotelu mogu podastrijeti medicinske dokaze o ovoj tvrdnji.
- Oslobađam Admiral Hotel bilo kakve odgovornosti za ozljede i/ili oštećenja koja bi moj pas mogao pretrpiti tijekom boravka u Hotelu.
- Suglasan/na sam da ću se za vrijeme boravka sa mojim psom u Hotelu pridržavati svih relevantnih zakona i propisa Republike Hrvatske.
